Religious Education Endowment

The cost to educate one child in the Religious Education Program is approximately \$200.00 a year. Families are asked to consider paying that fee rather than the regular registration fee. The extra amount will be put into the **Endowment Fund**. This revenue will be used exclusively for children coming for weekly religious instruction.

Any parishioner who would be in the position to contribute to the build up of this **Endowment Fund** is encouraged to do so. Our goal is to make it possible for families to pay the lower cost while the **Endowment Fund** would contribute the balance.
